The filing of a voluntary Chapter 11 petition automatically constitutes entry of an "order for relief" opening the case. 11 USC Â§ 301.

Should a debtor in possession fail to comply with the reporting requirements of the U.S. trustee or orders of the bankruptcy court, or fail to take the appropriate steps to bring the case to confirmation, the U.S. trustee may file a motion with the court to have the debtor's chapter 11 case converted to another chapter of the Bankruptcy Code or to have the case dismissed.
